• Meter Replacement Project – There are a total of 18 meters left to replace. Sheri Wheeler is going to send out certified letters by 10/1 giving a deadline of 10/25 to contact her regarding getting the meter replaced. They need to provide an installment date for when the work will be completed. At the next Authority meeting a decision can be made regarding shut off notices to anyone who does not respond. There was a total of 185 meters ordered for the project and 161 were installed.

• Issue Robinson Account – June Robinson's most recent water reading was very high. She had Mr. McKairnes come to her home and investigate for leaks. None were found. She does have a new meter that was installed a few years ago.
